# Required Documents for Membership

## Adult or Senior

1. Group A - Picture ID for identification
2. Group B - Proof of Residency

### **Group A - ID for Identification**

Driver's License/State ID/Military ID  
Passport

## Teen or College

1. Group A - Guardian picture ID for identification
2. Group B - Guardian proof of residency
3. Must provide one of the following:  
(required for initial membership only)
  - Report card, tuition statement, or class schedule (with same address as guardian)
  - Birth Certificate (with guardian's name)
  - Driver's License (with same address as guardian)

### **Group B - Proof of Residency**

## Family Membership

### **Primary Adult**

1. Group A - Picture ID for identification
2. Group B - Proof of Residency

### **Secondary Adult**

1. Group A - Picture ID for identification

\*If primary's proof of residency (Group B) has both primary and secondary names then no other documentation for Group B is required. If unable to provide joint documentation, then Group A and B documentation are required for each adult.

### **Children 23 and under must provide ONE of the following**

(required for initial membership only)

- Report card, tuition statement, or class schedule (with same address as primary)
- Birth Certificate (with either primary or secondary adult name)
- Driver's License (with same address as primary)
- Proof of legal custody

## AGE POLICY

### **ADULTS 18 & OVER**

- Full access to the entire facility including the 24/7 area after hours.

### **14 - 17 Year Olds**

- Full access to the entire facility during normal operating hours.
- MAY NOT use the 24/7 area after hours.

### **11-13 Year Olds**

- May use the basketball courts, running track, and pool **WITH** adult ***member*** supervision. Adult member must be in the same area/same floor.
- May use the 24/7 room, turf area, and cycling bikes upstairs **WITH** adult ***member*** supervision after completing the Teen Weight Room Orientation.
- MAY NOT use the 24/7 area after hours.

### **10 Years of Age and younger**

- May use the basketball courts, running track, and pool **WITH** adult ***member*** supervision. Adult member must be in the same area/same floor.
- MAY NOT use the 24/7 room, turf area, and cycling bikes upstairs.
- MAY NOT use the 24/7 area after hours.
